The meeting was held electronically due to the coronavirus pandemic, under the terms of NJ Public Law 2020, Chapter 11.

The president called the meeting to order at 7:03 pm. She led the salute to the Flag and read the Open Public Meetings statement. In the absence of the secretary, the interim director was appointed secretary pro tem. Ms. Massey read a resolution (attached) to go into closed session; a question was raised as to the necessity for meeting in closed session, and it was determined that it was appropriate. On motion and second (Massey/Krauze) it was voted by voice vote to go into closed session at 7:06 pm.

On motion and second (O'Neill/Krauze), it was voted to return to regular session at 8:16 pm. No actions were taken at this meeting as a result of the closed session.

Public Comment was enabled by monitoring a special email account. There were no public comments received during the allotted time.

There being no other business, on motion and second (Krauze/O'Neill) it was voted to adjourn at 8:18 pm.

## MINUTES OF THE EDISON TOWNSHIP LIBRARY BOARD OF TRUSTEES SPECIAL MEETING OF JULY 21 2020 (closed portion)

Absent/Excused: Neville Arestani.

<u>Also Present:</u> Dominick Bratti (board attorney), Keith McCoy (interim library director), Shanshan Ming (library staff/IT).

On motion and second (Massey/Krauze) it was voted by voice vote to go into closed session at 7:06 pm.

The first discussion item was a proposed reorganization of the library staff. Mr. McCoy presented two charts, one of the staff as of March 2020, and one with the proposed changes. He noted that, among the reasons for the proposal, too many people reported to just two supervisors, specifically the director and the Coordinator of Children's Services. The proposal would break the supervision of staff into smaller groups. The proposal also creates more uniform titles, has persons in supervisory titles actually supervise someone, and emphasizes services across branches rather than the branches themselves. There was a question as to whether this was the right time to do this. The consensus was that the reorganization should proceed as proposed.

The second discussion item was the search process for a new director. Mr. McCoy supplied the board with data about comparable library communities, the job description for director from NJ Civil Service, a recent advertisement for a new director, and a proposed time line. Questions were asked about the data, about the make-up of the search committee, and the proposed salary level. The president appointed Mmes. Krauze and O'Neill, Messrs. Ye and McCoy, and herself as the Search Committee; they will meet prior to the August board meeting to draft a job description and an advertisement, and finalize the process timeline.

On motion and second (O'Neill/Krauze), it was voted to return to regular session at 8:16 pm.

## RESOLUTION OF THE BOARD OF TRUSTEES OF THE EDISON TOWNSHIP FREE PUBLIC LIBRARY TO HOLD A CLOSED SESSION
