Whereas the township of Edison has established a free public library operated by a board of trustees; whereas the board of trustees desires to terminate certain positions reporting to the board of trustees as well as certain professional services that serve on behalf of the board of trustees; whereas the board of trustees desires to terminate the executive director effective immediately; whereas the board of trustees desires to terminate its council Shain Schaffer effective immediately and whereas the board of trustees desires to eliminate the position of chief of staffing effective immediately. Now therefore be it resolved by the board of trustees of the Edison Township public library the aforementioned resettles are incorporated herein as though fully set forth at length. The board of trustees hereby terminates its executive director, council and chief of staffing effective immediately. This resolution shall take effect immediately.

Lisa Krauze moved the adoption of the resolution terminating the director, terminating the Board's council Shain Schaffer and eliminating the position of chief of staffing.
